Established in 2000, the Manufactured Housing Consensus Committee advises HUD's Secretary on manufactured housing construction and safety standards. The Committee also provides advice on federal procedural and enforcement regulations for manufactured housing. The new appointments and reappointments include:

- Loretta Dibble has served her first term as MHCC member. She is a manufactured home owner and the former President of Paradise Park Homeowners Association. Currently, she serves as a board member of New Jersey Manufactured Home Owners Association and the National Manufactured Homeowners Association (NMHHOA). She has conducted disaster outreach in manufactured housing communities since Hurricane Sandy in 2012, serving as part of the National Low-Income Housing Coalition Disaster Recovery Network.
- **Stacey Epperson** is the President and Founder of Next Step Network, Inc. She leads efforts to educate prospective buyers and assist consumers of manufactured housing.
